3. David Mason made the motion to approve the minutes of the Regular Meeting April 10, 2023. Dana Matson seconded the motion. Vote 4 for.

11. Bobby Wesner made the motion to accept the bid from Live Oak Technology in the amount of \$2,250.00 to change/upgrade email service. David Mason seconded the motion. Vote 4 for.

12. David Mason made the motion to accept the generous donation from Burleson County to the police department. Dale Phelps seconded the motion. Vote 4 for.


13. The Financial/Budget reports, Police reports, Code Enforcement report, Public Works report, Mayor/Council reports were given.
