

## **REGULAR MEETING**

The Lexington City Council met in a Regular Meeting on Monday, May 13, 2024, at 6:00 p.m., at City Hall, 604 Wheatley, Lexington, Texas.

Present was Mayor Allen Retzlaff, Councilpersons David Mason, Dale Phelps, Bobby Wesner and Anthony Retzlaff.

Mayor Retzlaff brought the Regular Meeting to order and welcomed the guests.

2. Citizen Comments: None

3. Anthony Retzlaff made the motion to approve the Regular Meeting minutes of April 8, 2024. Dale Phelps seconded the motion. Vote 4 for.

4. Bobby Wesner made the motion to approve paying the bills with the exception of Item No. 3 on the List of Monthly Bills for the month of April, 2024. Anthony Retzlaff seconded the motion. Vote 4 for.

5. No action was taken on this agenda item regarding utility department hire as it was decided in the prior Special Meeting.

6. Anthony Retzlaff made the motion to adopt Ordinance No. 24-0513-6, an ordinance amending the City's Code of Ordinance by adding Chapter 79 Mobile Food Establishments, regulating mobile food establishments within the City of Lexington. David Mason seconded the motion. Vote 4 for.

7. Anthony Retzlaff made the motion to adopt Ordinance No. 24-0513-7 increasing the security light fee to \$18.00/month, adding a \$35.00 install fee and placing them on the fee schedule. David Mason seconded the motion. Vote 4 for.

8. Bobby Wesner made the motion to place ad in paper to bid out city hall renovations with security upgrades. Anthony Retzlaff seconded the motion. Vote 4 for.

9. Bobby Wesner made the motion to approve the EDC's budget amendment to include the purchase of Motorola radios for the Lexington Police Department in the amount of \$59,937.08 and further move to amend the City's budget to accept the \$59,937.08 for the purchase of the radios. Dale Phelps seconded the motion. Vote 4 for.

10. David Mason made the motion to table action on the lease agreement with Atlas Tower. Bobby Wesner seconded the motion. Vote 4 for.

11. The Financial/Budget reports, Police reports, Code Enforcement report, Public Works report, Municipal Court report and Mayor/Council reports were given.

12. The 2024 Election results were canvassed by Anthony Retzlaff and Bobby Wesner; results were as follows:
